I am writing with massive concerns over the plan to build another 2500 houses in Haverhill. Infrastructure in Haverhill is already overstretched and with these added houses, plus the already approved 1500, the town is just becoming a large housing estate. The population of

Haverhill is not that different to Bury St Edmunds, however the infrastructure is massively different. See below:

In Haverhill two of our biggest employers are reducing jobs (Sanofi and Collina), and the business park is completely empty!!!

We have no hospital, and GP provision is terrible. The walk in centre was taken away which was an absolutely ridiculous decision.

Our Police station is closing, PCSO and officer numbers are reducing.

We have no 24/7 manned fire station anymore.

Roads within the town are deteriorating, and roads to major towns and cities are blocked already. The A1307 needs major work and should have happened 10 years ago. We have no train station so rely on the road network.

Schools are already over subscribed.

Haverhill wants and needs its fair share of investment to support these houses. Infrastructure needs to be prioritised and not more housing!
