We are writing to express our objections to the planned development at Great Wilsey Park development. Although we have attended all the meetings regarding this planned development and really felt that the objections we raised were not listened to.

One of our main objections is the extra traffic that will be utilising Chalkstone Way and surrounding areas. Chalkstone Way cannot cope with the amount of traffic now. The new site is supposed to have 2,500 new homes, factory units, school, shops and doctors surgery. If you take it that each home will have at least 1 car, that is an extra 2,500 cars that will be using Chalkstone

Way and surrounding areas. As most homes will probably have 2 or more cars the volume will increase to at least 3000/4000 cars.
