The Huge Development planned in Haverhill despite another large build of 1,500

planned in Haverhill .Haverhill had population of 26,000 which increased 5,000 since 2011 with our many problem we suffer in the town with infrastructure,Healthcare transport,schools,lack of facilities.A poor shopping centre mainly because of the high Cambridge post code giving hire business rates,We have to travel over an hour to our nearest hospitals by bus.

We live on the Chalkstone estate the problems we suffer now are heavy traffic with as we live next to the road side where there is a large flat topped speed bump

creates Noise and Vibration,stagecoach and stephenson double decker buses travel through the chalkstone 3 every hour from 5.15 am to 0;35 am after midnight which produces a lot of noise vibration contributes damage to render.This plus added traffic will Devalue our house and ruin our enjoying the garden.

It is very hard to travel by car and not have problems at the wratting road end

trying to exit,we have 3 schools and a care home which should come first.parents and staff having problems now.even if you put in a traffic lights would not help.

We do object to the proposed use of chalkstone way to filter traffic from the Wilsey

Development, and we think it is very irresponsible of the planning department to put such a large build here in Haverhill when it could mean with the other build an increase of 4,000 new homes and an increase in population of 8,000 to 16,000

when we hear of other towns complaining of a couple of hundred.

We know the government wants to build a million houses but why so many in Suffolk ? and Haverhill and many villages will be swamped.

The traffic alone if the average home has 2 cars we are looking at 5,000.

If the build of so many houses and schools go ahead then we need to see a by pass that comes out either end one side onto sturmer road passed spring cottages and the other end higher up Wratting Road where the fields are and not use chalkstone way this would aid the flow of traffic.
