Dear Suzanne,

Thank you for sending me these documents. I had concerns that the recent dormouse footprint tunnel survey did not conform to CIEEM protocol, lasting only 2 months instead of the minimum 3 months. This is not enough to produce certainty of a negative result. However, the Biodiversity Monitoring Strategy and the Ecological Implementation Strategy (both Ecology Solutions, April 2019) are sufficiently robust to ensure appropriate mitigation.

I have no further comments on this application.
