T3/G1 Beech lateral reduction on lowest limbs by 2m, and reduce by 2m in height to form as a managed tree line
T4/G1 Beech lateral reduction on lowest limbs by 2m
T5/G1 Beech to 2m reduction in height to previous points and remaining crown by 1m to balance and shape
