These have been updated following our discussions with Colin Bird at Suffolk County Council, and the requirement to show how the B2 parking standards can be accommodated. As previously advised Colin has accepted these layouts in principle and trust that his objection, along with that of the Haverhill Town Council can now be removed. As the yard layout has had to be amended we have also updated the B8 parking standards layout to match.

To accommodate the changes the service yard doors have had to be relocated, therefore the Unit 1 Plans, Elevations and Sections have been re - issued to reflect the changes.

There has also been considerable interest in Unit 2 from potential occupiers, however the majority have a requirement for offices at first floor level, therefore the Unit 2 Plans, Elevations and Sections have been re-issued to reflect this requirement. The amount of B2 and B8 car parking has been increased to comply with this change.
