Dear Penny,

I would not advise discharge of condition A8 as there are still outstanding archaeological works.

I would like to refer to Rachael Abraham's email dated 26th June 2019 attached " On site archaeological work has been completed for the phase 1 housing development area (the area covered by RM application DC/16/2836) and the first section of the access road however, the remainder of the housing development phases and the rest of the road still require further archaeological work."

Having reviewed the 2007 evaluation report I have attached is a plan showing three areas in purple where evaluation work still needs to be carried out and two areas in blue where targeted archaeological excavations will need to be carried out, although these may need to be expanded if significant archaeological remains are identified.. Depending on the results of the evaluations there may need to be additional targeted excavations.
