SCC Flood and Water Management have reviewed the proposed landscape plans and currently recommend a holding objection and require further information.

- 1. We advise that where the replacement hedge is located on or near to a SuDS embankments there should not be any deep rooting plants in the mix. Our concern is the increased risk of desiccation in the clay banks beyond acceptable limits in the summer months. We suggest just using hedge along the sections that are SuDS embankments.
- 2. There also appears to be a tree within the northern watercourse, located at the western corner of the Northern basin. This is not acceptable if this is a proposed tree.
