I am validating your application for tree works at 4 Hamlet Road.

We need a full proposal with measurements and are unable to accept "cut back".

I believe you would like to do a crown reduction. We need to know what is being reduced for a crown reduction. If it's an overall crown reduction or a reduction to one side of the crown (using compass points)- this must be given in metres e.g. Overall crown reduction by two metres or Lateral crown reduction on eastern aspect by up to two metres.

Please get a response back to me by tomorrow 7th November or this application will have to be returned.
