Hi Tom,

Thank you for the photos which are really helpful. Given the ability to appreciate views of the panels on the single storey element in context with the principal elevation I do not believe their installation on this roof slope would preserve the special architectural or historic interest of the building particularly as this would also appear to involve their provision on a more historic extension. The removal of the panels from the southern roof slope of the single storey extension are therefore recommended.

Whilst views of the panels on the more modern extension will be possible in context with the host dwelling, due to the orientation of the extension, views will not be fully appreciated head on with the principal elevation. Furthermore, the panels will not be located on an historic roof slope. Taking into account location, age, orientation and limited ability to appreciate these panels in context with the principal elevation I raise no objections to this element of the proposal.
