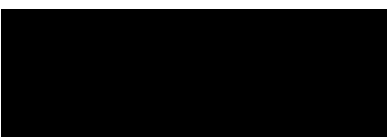
I will of course keep you updated over the next few weeks. Please do not hesitate to contact me should you wish to discuss.
