I write to submit my objection to the plans for an incinerator at the entrance to Haverhill along the 1307 heading from Cambridge, London etc.

Several of these plants have encountered disasters to include explosions and leaks where residents have been asked to stay in and close all windows for days. This plant is too near to Haverhill and its residents.

One of my objection is the destruction to the health of people living near the site due to the smell and toxic fumes. As you know Haverhill has a high incidence of people with lung disease having migrated from the fog and smog of London in the 60s and 70s. Perhaps this is a way to relieve the burden of this section of the population upon the national health service.

The volume of traffic to and from Haverhill generated by this plant will be detrimental to the roads which are already full of potholes and winter is not upon us yet.
