With regards to the proposal for the above plant in Withersfield, Haverhill, I would like to put forward to you my strong objections to this proposal.

Unfortunately if this location proposal is granted now, or, at some point in the future, I feel that it will be to the detriment of many people who live in this area and likewise for businesses too, not to mention the issues that it would create for the environment and wildlife with the removal of trees and hedges destroying their habitats.
